

#### Roane County Anti-Drug Coalition (RCADC) November 1, 2023

Nathan Wray opened the meeting and gave an update on the Handle with Care program, which is part of our Drug Endangered Children grant through the Tennessee Bureau of Investigations (TBI). A meeting was held at our office last month with representatives from the TBI, local law enforcement representatives and first responders, Roane County Schools and other county agencies. Handle with Care provides communication between first responders and school administrators to give the school a "heads up" when a child has been identified at the scene of a traumatic event. We anticipate that this program will be initiated in Roane County within the next year.

Sarah Harrison reported that our coalition has been chosen to participate in a project with our national partner, Community Anti-Drug Coalitions of America, to host a statewide webinar to provide education on opioid overdose prevention and response, with a special focus on Naloxone. The webinar is scheduled for early March. More information will be provided as the project progesses.

The DEA's National Prescription Drug Take Back Day took place on Saturday, October 28<sup>th</sup>. There were four locations in Roane County including Kingston City Hall, Walgreens in Harriman, Rockwood Police Department and Food City in Oliver Springs. We do not have the total number of pounds collected yet, but will relay this information when we get it.

Sandy Leavell, the Executive Director of the United Way of Roane County was our speaker for the day. Sandy has been in this position since 2022. The three priority areas of the United Way are health, education and financial stability. They currently fund 14 local nonprofit agencies covering 16 programs.

The presentation slides are attached to the end of this document, but some highlights include:

Through meals, education, and advocacy the United Way of Roane County served over 4000 individuals with 67,000 services in 2022.

The local United Way is part of the United Way of Tennessee has four focus areas including human trafficking, homelessness, suicide awareness and prevention and domestic violence support.

Sandy reported on the most recent local Asset Limited, Income Constrained, Employed (ALICE) data- 39% in Roane County fall within the poverty guidelines or the ALICE guidelines; 8,274 households in Roane County fall below the ALICE threshold, which means they are unable to afford basic necessities.

For resource referrals you can dial 211.

The Tennessee Benefit Kitchen provides families with a list of services they qualify for. To begin this process text the word benefits to 211211.

The United Way is working on purchasing software to provide poverty simulation training. This is a three hour training that can be targeted to many different audiences. Two groups they would like to target are elected officials and local churches.

#### **Community Updates**

Leonora Spangler announced that the Community Action Board's teen stocking project is underway again. Donations are being collected at several sites across the county- the Juvenile Court office, RCADC, the Roane Alliance, the Spot, Harriman municipal building, Rockwood municipal building and the United Way.

We will not have a coalition meeting in December. Our next meeting will be on Wednesday, January 3, 2024 at 12pm at the RCADC office.


